WHEREAS, the RSA departments may not hire in excess of the approved number of positions in job classification as indicated by the budget detail without the consent of the Board of Directors; and

NOW, THEREFORE, THE REDEVELOPMENT SUCCESSOR AGENCY OF THE CITY **OF RIALTO DOES HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:**

Section 1: That the Redevelopment Successor Agency of the City of Rialto amends its 2017-2018 fiscal budget as defined in Exhibit "A" per the Mid Year Review recommendations.
