#### **AMENDMENT NO. 4**

It is hereby agreed to amend contract No. 14-614, effective July 1, 2018, as follows:

### III. FISCAL PROVISIONS

Paragraph A is amended to read as follows:

A. The maximum amount of reimbursement under this Contract shall not exceed \$1,546,060. The consideration to be paid to County, as provided herein, shall be full payment for all County's services and expenses incurred in the performance hereof, including travel and per diem. The maximum amount is a total dollar amount that includes the original contract amount and all subsequent amendments, broken down as follows:
