A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO, CALIFORNIA, QUITCLAIMING AN EASEMENT FOR WATER DRAINAGE AND FLOWAGE PURPOSES TO LHR RENAISSANCE MARKETPLACE NORTH, LLC

WHEREAS, On April 1, 1963, the City of Council accepted an interest in real property conveyed by the (Easement) from Louis W. Hadjes, Delbert B. Williams, Fred W. Gutekumss, & Nathan Goodman, William J. Sanborn trustees for Max Goodman, Decedent. The easement is for water purposes with the right to install, repair and maintain the easement over and across the real property in the City of Rialto, County of San Bernardino, and State of California, as further described in the Quitclaim Deed attached hereto as Attachment 1 and incorporated herein ("Easement"), and specifically described in the legal description and depiction on Exhibits "A" and "B," respectively, attached thereto (the "Easement Area"); and

WHEREAS, On November 7, 1966, the City Council of Rialto ("City") adopted Resolution No. 1258 annexing an area generally described as an area of land located north of Base Line Road, east Cactus Avenue, south of Walnut Avenue, west of Spruce Avenue, south of Interstate 210, east of Locust Avenue, north of Walnut Avenue, and east of Linden Avenue ("Annexation 92"); and

WHEREAS, the Easement Area is located within Annexation 92; and

WHEREAS, pursuant to Government Code Section 57325, the Offer automatically transferred to the City upon the annexation of the Easement Area in Resolution No. 1258; and

WHEREAS, the Easement No. 444 was accepted; and

WHEREAS, pursuant to Government Code Section 7050, the City may quitclaim the Easement, making the right to accept such offer abandoned, in the same manner as is prescribed for the summary vacation of streets or highways pursuant to Streets & Highway

Code Section 8300, et seq.; and

WHEREAS, the City Council now desires to quitclaim Easement No. 444.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

Section 1. That the City Council does hereby approve the Quitclaim Deed abandoning Easement No. 444 (a copy of which Quitclaim Deed is attached hereto and incorporated herein as Attachment 1, which describes the Easement Area, per the legal description and depiction on Exhibits "A" and "B," respectively, attached thereto and incorporated therein. The City Council further directs and authorizes the City Administrator to execute such Quitclaim Deed and take all actions necessary to accomplish the action approved by the City Council herein.

That the City Clerk is hereby directed to cause a certified copy of this Section 2. Resolution, attested by the City Clerk under the seal of the City, to be recorded in the Official Records of San Bernardino County and from and after the date of the resolution is recorded, the public service easement for water drainage and flowage purposes (as set forth in the Quitclaim Deed) is vacated and no longer constitutes a public easement.

Section 3. If any section, subsection, sentence, clause, phrase or portion of this Resolution is held invalid or unconstitutional by any court of competent jurisdiction, such determination shall not affect the validity of the remaining portions of this resolution. The City Council declares that it would have enacted this resolution and each section, subsection, sentence, clause, or phrase hereof irrespective of any determination of invalidity.

This Resolution shall become effective immediately upon adoption. Section 4. PASSED, APPROVED AND ADOPTED this 12th of June, 2018.
