A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO, STATE OF CALIFORNIA DEDICATING PORTIONS OF THAT CITY-OWNED PROPERTY LOCATED WITHIN THE RENAISSANCE SPECIFIC PLAN AS PUBLIC RIGHT-OF-WAY FOR SCHOLL WAY.

WHEREAS, on November 7, 1966, the City Council of the City of Rialto, (the "City"), adopted Resolution No. 1258, Accepting Annexation Area No. 92 where Scholl Way is located; and

WHEREAS, on August 8, 2017, the City adopted Resolution No. 7177 approving portions of Annexation Area No. 92 to be subdivided into twenty-eight developable parcels of land and one (1) lettered lot to facilitate the development of the Retail and Commercial Shopping Center known as Renaissance Marketplace; and

WHEREAS, the City owns approximately 437.5 acres of land adjacent to and within the Rialto Municipal Airport, to be redeveloped as the Renaissance Specific Plan, (the "Property"); and

WHEREAS, the Property was acquired by the City by that certain Quitclaim Deed recorded September 13, 2012, as Document No. 2012-0377024; and

**WHEREAS,** the City, through its adoption of the Renaissance Specific Plan, has proposed the creation of Scholl Miro Way as a public street from Ayala Drive to 420 feet west of Ayala Drive as a commercial cul-de-sac; and

WHEREAS, in order to facilitate construction of Scholl Way and its use as a public street, it is necessary to dedicate the right-of-way for public street and public utility purposes for Scholl Way across the Property; and

WHEREAS, in accordance with the California Streets and Highways Code Section 1806(b), no public street or road shall become a city street or road until the governing body, by resolution, has caused the street or road to be accepted into the city street system; and

WHEREAS, the City Council wishes to declare its intention to dedicate a portion of the Property as public right-of-way for Scholl Way within the Renaissance Specific Plan extending across the Property between Ayala Drive and approximately 420 feet west of Ayala Drive, as described in Exhibit "A", and shown on Exhibit "B", attached hereto and by reference incorporated herein

## NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

**Section 1:** The above recitals are true and correct.

<u>Section 2:</u> In accordance with California Streets and Highways Code Section 1806(b), the City Council hereby approves the Grant of Right-Of-Way attached hereto and incorporated herein as Attachment No. 1 dedicating those certain portions of City-owned property described in Exhibit "A" and shown on Exhibit "B", attached thereto as an easement and right-of-way for public street and public utility purposes. The City Council further authorizes the City Administrator to execute said Grant of Right-Of-Way and take all actions necessary to uphold the action approved by this Resolution.

Section 3: Nothing contained in this Resolution shall be deemed or interpreted by any party to cause any interested created in the public pursuant to this Resolution to ripen into any title, interest or right of the public against or adverse to the rights of the City of Rialto, nor shall this Resolution limit, restrict or modify the exemption of public property to title by prescription as defined within California Civil Code Section 1007.

**Section 4:** The City Clerk of the City of Rialto shall certify to the passage of this Resolution and attest thereto under the seal of the City of Rialto.
