

RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO, ACCEPTING THE SB-1 PUBLIC TRANSPORTATION ADAPTATION PLANNING GRANT AND AMENDING THE FISCAL YEAR 2017-2018 BUDGET.

WHEREAS, the budget for fiscal year 2017-2018 of the City of Rialto has been adopted by this Council in its original form, and said budget will need to be amended at times to fulfill the goals of the City; and

WHEREAS, the City departments may not exceed their appropriations by character of expense, with character of expense being defined as personnel services, services and supplies, capital outlay, debt service and transfers, without the consent of the City Administrator; and

WHEREAS, the City Administrator may transfer appropriations, between departments and within their respective funds, as long as those appropriations do not exceed their fund total unless approved by Council.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

Section 1: Accept the California SB-1 Public Transportation- Adaptation Planning Grant and authorize increase revenues of \$350,000 in the SB-1 Fund Account Number 203-400-7305-7536-180811-22, for the Rialto Climate Adaptation Plan; and

Section 2: Authorize the appropriation of \$350,000 in the SB-1 Fund Account Number 203-500-7305-3001-140809-01 and in the Measure I Fund Account No. 201-500-4310-2011-180811-04 for \$45,500 matching requirement for the Rialto Climate Adaptation Plan.
