RESOLUTION NO. 1 2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF 3 DIRECTING THE PLACEMENT NASTEWATER CHARGES ON THE PROPERTY TAX BILLS 4 FOR COLLECTION 5 6 7 WHEREAS, Section 12.08.201 of the Rialto Municipal Code provides that delinquent 8 wastewater charges are considered for submittal to the County of San Bernardino to be included on the Annual Property Tax bill as a lien; and 9 10 WHEREAS, California Health and Safety Code Section 5473 specifically authorizes the 11 City to levy and collect wastewater charges through County administered and enforced 12 property tax billing and collection procedures; and 13 WHEREAS, the Auditor-Controller of San Bernardino County is authorized, if so 14 directed by the City, to place wastewater charges on property tax bills; and 15 WHEREAS, the City Council has elected to transition the placement of delinquent 16 wastewater charges on the property tax rolls. 17 NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY 18 FIND, DETERMINE, AND RESOLVE AS FOLLOWS: 19 Section 1: That the delinquent wastewater charges as of June 30, 2018 of those 20 customers who maintain ownership of the property with delinquent charges as of the latest 21 County Secured Property Tax Roll and as identified on Exhibit "A" are hereby approved for 22 levy on the annual property tax bill of the respective properties and shall be forwarded to the 23 County of San Bernardino for addition to the Fiscal Year 2018/2019 property tax rolls as a 24 special assessment. 25 ///
