3 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
4 RIALTO, CALIFORNIA AUTHORIZING THE CITY  
5 EMPLOYEES' COMPENSATION RATES AND SCHEDULE FOR  
6 THE 18-19 FISCAL YEAR

7 WHEREAS, the City's Municipal Code, Section 2, and the City's Personnel Rules, Section  
8 IV, provide, in part, that any additional compensation or benefits to employees be approved by  
9 resolution by the City Council ; and

10 WHEREAS, on June 26, 2018, the City Council has authorized Tentative Agreements with  
11 the Rialto Police Officers' Association, General Bargaining Unit, and the Rialto Police Officers'  
12 Association, Management Bargaining Unit, for the term August 1, 2016 through June 30, 2019; and

13 WHEREAS, the City Council desires to establish new salary rates for the Rialto Police  
14 Officers' Association, General Bargaining Unit, and the Rialto Police Officers' Association,  
15 Management Bargaining Unit, in accordance with the Tentative Agreements;

16 NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES  
17 HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

18 Section 1: That the City of Rialto approve an eight percent (8%) salary increase to Rialto  
19 Police Officers' Association, General Bargaining Unit, and the Rialto Police Officers' Association,  
20 Management Bargaining Unit, members.

21 Section 2: That the City Council incorporate the 8% salary increases into the employees'  
22 compensation rates and salary schedule for the 18-19 fiscal year as provided in Exhibit A.

23 Section 3: That the increases become effective the first full pay period in July 2018.
