A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO, CALIFORNIA, REQUESTING THE BOARD OF SUPERVISORS OF THE COUNTY OF SAN BERNARDINO CONSOLIDATE A GENERAL MUNICIPAL ELECTION TO BE HELD ON TUESDAY, NOVEMBER 6, 2018 WITH THE STATEWIDE GENERAL ELECTION OT BE HELD ON THE SAME DATE, PURSUANT TO SECTION 10403 OF THE ELECTIONS CODE OF THE STATE OF CALIFORNIA

WHEREAS, the City Council of the City of Rialto called a General Municipal Election to held on Tuesday, November 6, 2018, for the purpose of the election of, two members of the City Council; and

WHEREAS, it is desirable that the General Municipal Election be consolidated with the
Statewide General Election to be held on the same date and that within the City the precincts, polling
places and election officers be the same, and that the Elections Office of the Registar of Voters of San
Bernardino County canvass the returns of the General Municipal Election and that the election be held
in all respects as if there was only one election.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

<u>Section 1:</u> That pursuant to the requirements of *Section 10403 of the Elections Code of the State of California*, the Board of Supervisors of the County of San Bernardino is hereby requested to consent and agree to the consolidation of a General Municipal Election with the Statewide General Election on Tuesday, November 6, 2018, for the purpose of the election of certain officers of the City.

Section 2: That the election will be held and conducted in accordance with the provisions of law regulating the statewide election.

Section 3: That the Elections Office of the Registar of Voters of San Bernardino County is authorized to canvass the returns of the General Municipal Election. The election shall be held in all respects as if there were only one election, and only one form of ballot shall be used.

 Section 4:
 The Board of Supervisors is requested to issue instructions to the Registrar of

 Voters Office to take any and all steps necessary for the holding of the consolidated election.

1	Section 5: That the City of Rialto recognizes that additional costs will be incurred by the
2	county by reason of this consolidation and agrees to reimburse the county for any such additional costs.
3	Section 6: That the City Clerk is hereby directed to file a certified copy of this resolution
4	with the Board of Supervisors and the Registrar of Voters Office of the County of San Bernardino.
5	Section 7: That the City Clerk shall certify to the passage and adoption of this resolution
6	and enter it into the book of the original resolutions.
