3 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO,
4 CALIFORNIA, ADOPTING REGULATIONS FOR CANDIDATES FOR
5 ELECTIVE OFFICE PERTAINING TO CANDIDATES' STATEMENTS
6 SUBMITTED TO THE VOTERS AT AN ELECTION TO BE HELD ON
7 TUESDAY, NOVEMBER 6, 2018

8 WHEREAS, Section 13307 of the Election Code of the State of California provides that the
9 governing body of any local agency adopt regulations pertaining to materials prepared by any candidate
10 for a municipal election, including costs of the candidates statements;

11 NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES
12 HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

14 **SECTION 1. GENERAL PROVISIONS** That pursuant to *Section 13307 of the Elections*
15 *Code of the State of California*, each candidate for elective office to be voted for at an Election to be
16 held in the City of Rialto on Tuesday, November 6, 2018, may prepare a candidate's statement on an
17 appropriate form provided by the City Clerk. The statement may include the name, age and occupation
18 of the candidate and a brief description of no more than 200 words of the candidate's education and
19 qualifications expressed by the candidate himself or herself. The statement shall not include party
20 affiliation of the candidate, nor membership or activity in partisan political organizations. The
21 statement shall be filed in typewritten form in the office of the City Clerk at the time the candidate's
22 nomination papers are filed. The statement may be withdrawn, but not changed, during the period for
23 filing nomination papers and until 5:00 p.m. of the next working day after the close of the nomination
24 period.

25 **SECTION 2. SPANISH LANGUAGE** That the City Clerk shall have translated and printed in
26 the voters pamphlet only the candidates statements of those candidates who request translation and
27 printing in the Spanish language
