3 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
4 RIALTO, CALIFORNIA, ADOPTING A RESOLUTION TO
5 CONTINUE THE BUDGET FOR FISCAL YEAR COMMENCING
6 JULY 1, 2017 AND ENDING ON JUNE 30, 2018

7 WHEREAS, the City has duly passed the Fiscal Year 2017-18 budget; and

8 WHEREAS, the presentation of the Fiscal Year 2018-19 operations budget is scheduled for City
9 Council consideration on July 10, 2018; and

10 WHEREAS, the Fiscal year 2017-18 budget ends on June 30, 2018; and

11 WHEREAS, the City Council deems it appropriate to continue the operation of City services
12 and contracts until the passage of the Fiscal Year 2018-19 budget; and

13 WHEREAS, State Law allows entities to pass a resolution continuing the prior year's operating
14 budget.

15 NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES
16 HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

17 Section 1: That the City Council of the City of Rialto does continue the 2017-18 annual
18 budget, adjusted for adopted compensation increases duly approved by separate action of the City
19 Council, in full force and effect until August 30, 2018 or adoption of the Fiscal Year 2018-19 budget,
20 except for capital expenditures which may require City Council approval.
