2 **A RESOLUTION OF THE RIALTO HOUSING AUTHORITY, THE**
3 **CITY OF RIALTO, CALIFORNIA, ADOPTING A RESOLUTION**
4 **TO CONTINUE THE BUDGET FOR FISCAL YEAR**

11 and contracts until the passage of the Fiscal Year 2018-19 budget; and

12 **WHEREAS**, State Law allows entities to pass a resolution continuing the prior year's operating
13 budget.

14 **NOW, THEREFORE, THE RIALTO HOUSING AUTHORITY OF THE CITY OF**
15 **RIALTO DOES HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:**

16 **Section 1:** That the Rialto Housing Authority of the City of Rialto does continue the 2017-18
17 annual budget in full force and effect until August 30, 2018 or adoption of the Fiscal Year 2018-19
