2 A RESOLUTION OF THE RIALTO UTILITY AUTHORITY, THE
3 CITY OF RIALTO, CALIFORNIA, ADOPTING A RESOLUTION
4 TO CONTINUE THE BUDGET FOR FISCAL YEAR
5 COMMENCING JULY 1, 2017 AND ENDING ON JUNE 30, 2018

6 WHEREAS, the Authority has duly passed the Fiscal Year 2017-18 budget; and

7 WHEREAS, the presentation of the Fiscal Year 2018-19 operations budget is scheduled for City
8 Council consideration on July 10, 2018; and

9 WHEREAS, the Fiscal year 2017-18 budget ends on June 30, 2018; and

10 WHEREAS, the Authority deems it appropriate to continue the operation of Authority services
11 and contracts until the passage of the Fiscal Year 2018-19 budget; and

12 WHEREAS, State Law allows entities to pass a resolution continuing the prior year's operating
13 budget.

14 NOW, THEREFORE, THE RIALTO UTILITY AUTHORITY OF THE CITY OF
15 RIALTO DOES HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

16 **Section 1:** That the Rialto Utility Authority of the City of Rialto does continue the 2017-18
17 annual budget in full force and effect until August 30, 2018 or adoption of the Fiscal Year 2018-19
18 budget, except for capital expenditures which may require Authority approval.
