18	Section 1: Authorize the appropriation of \$4,069,000 in the Fire Development
19	Impact Fund Account Number 217-500-5176-3001-05, and \$50,000 in the Fire Development
20	Impact Fund Account Number 217-500-5176-3001-15 for a total of \$4,119,000;
