we are looking at the week of 12/17/2018 for contractor & tech to perform this work.

Mechanical

- Air Filter is plugged and dry rotted/falling apart
- Only 1 PVRV is on the gas standpipe, the second one is off because that is where they have the hose attached. The pallet for the PVRV will need to be replaced/rebuilt and a few more lead weights are required since this one is mostly destroyed from venting.
- There is a blind flange on the air purge piping (PVC) that is cracked and should be replaced.
- Overflow piping needs to be capped off as mentioned above.
- Temporary hose is cloth and has many holes with duct tape holding it together. When this is put into operation they will not need this hose anymore.

Electrical

- The HMI screen is destroyed and no longer works.
- SCADA hookup is not complete. There are wires connected to the contacts from the PLC output. I do not know if they need additional tags from the PLC program
