**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
RIALTO FINDING THAT THE PUBLIC PURPOSE WOULD BE
SERVED BY THE PROVISION OF CITY RESOURCES AND
FUNDING FOR THE HOLIDAY ON ICE EVENT AND APPROVES
THE EXPENDITURE OF \$20,000.**

HOLIDAY ON ICE 2018

WHEREAS, the City Council approves of conducting a Holiday on Ice event; and

WHEREAS, the City Council approves of the expenditure of \$20,000 to provide co-sponsorship
of the Holiday on Ice event;

WHEREAS, the City Council is advised that if the City of Rialto is to expend public funds in
whole or part, the event should serve a public purpose and be formally approved by City Council,
including any funding or in-kind contributions for same; and

WHEREAS, if funds are used for a public purpose of the city making the expenditure, they are
not a gift within the meaning of Cal Const art XVI, §6. (*County of Alameda v Janssen* (1940) 16 C.2d
276, 281.); and

WHEREAS, the Holiday on Ice event is scheduled to be held within the City as a part of the
City's larger scope of events; scheduled on the calendar as a part of a collaborative effort, an historical
significance, and/or by the City having taken a role as a co-sponsor; and

WHEREAS, the Holiday on Ice for 2018, is intended to be a guide for the members of City
Council in its deliberations to decide whether the events as stated and/or amended will continue to be a
part of the 2019 calendar of special events; and

WHEREAS, by this Resolution, the City Council wishes to approve Holiday on Ice for 2018,
finding that the event serves the legitimate public purpose(s) stated therein.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF
RIALTO, CALIFORNIA AS FOLLOWS:**

Section 1. That the above recitals are true and correct.

Section 2. The City Council has considered Holiday on Ice, and hereby finds that this event serves the legitimate public purpose(s) insofar as it provides a winter recreational event as a part of the City of Rialto continuing effort to sponsor events that promote family oriented recreation opportunities. . As such, the City Council hereby approves the Holiday on Ice for 2018, as well as the \$20,000 financial contribution by the City, whether by direct funding or donation. The City Council further directs that the information provided about such event appropriately designate the City of Rialto as the host, a participant or sponsor of such event, as appropriate.
