A JOINT RESOLUTION OF THE RIALTO UTILITY AUTHORITY AND CITY COUNCIL OF THE CITY OF RIALTO, STATE OF CALIFORNIA, ADOPTING THE 2018 SEWER SYSTEM MANAGEMENT PLAN

**WHEREAS**, the City of Rialto (City) owns and operates more than one mile of public sewer line; and

WHEREAS, on May 2, 2006, the State of California Water Resources Control Board adopted Waste Discharge Order No. 2006-003-DWQ, Statewide General Waste Discharge Requirements for Sanitary Sewer Systems that applies to all public agencies that own and maintain more than one mile of sewer line; and

WHEREAS, the goal of the General Waste Discharge Requirements is to eliminate the occurrence of preventable sanitary sewer overflows by requiring public agencies to develop and implement written programs that improve the effectiveness and sustainability of existing systems; and

**WHEREAS**, the City is required by the General Waste Discharge Requirements to adopt a Sewer System Management Plan (SSMP) that identifies practices, procedures, and goals that comply with the provisions of the General Waste Discharge Requirements prior to August 2, 2009;

NOW, THEREFORE, THE RIALTO UTILITY AUTHORITY AND CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

Section 1: The Sewer System Management Plan, as updated during October 2018, is hereby adopted by the City of Rialto and the Rialto Utility Authority.
