RE:

2018-19 Budget Year Police Patrol Division Vehicle Replacements

On September 11, 2018 the Fleet Maintenance Division delivered 6 vehicle bid packets to local dealerships requesting bids on three (3) new Police Packaged Dodge Chargers. The bids closed on September 19, 2018 at 10:00am. The sealed bids were opened the same day. We had three (3) responsive bidders. Wondries Fleet Group (Bravo CDJR of Alhambra) was the lowest bidder. The total purchase price for the three (3) new vehicles is \$81,769.71.

The 2018-19 budget will support the purchase of the three (3) new patrol vehicles. With the conclusion of the sealed bid process and complying with the City's bid producers I am recommending that we precede with the purchase of the following:
