2 A RESOLUTION OF THE PLANNING COMMISSION OF THE
3 CITY OF RIALTO, CALIFORNIA, RECOMMENDING THAT
4 THE CITY COUNCIL APPROVE TENTATIVE TRACT MAP NO.
5 2017-0006 (TTM No. 20108) TO ALLOW THE SUBDIVISION OF
6 4.75 ACRES OF LAND (APNS: 0131-111-05, -07, -75 & -76)
7 LOCATED EAST OF SYCAMORE AVENUE APPROXIMATELY
8 630 FEET NORTH OF RANDALL AVENUE INTO THIRTY-TWO
9 (32) SINGLE-FAMILY LOTS, ONE (1) COMMON OPEN SPACE
10 LOT AND A STORMWATER RETENTION BASIN.

WHEREAS, the applicant, Asian Pacific, Inc., proposes to subdivide 4.75 acres of land (Portions APNs: 0131-111-05, -07, -75 & -76) located east of Sycamore Avenue approximately 630 feet north of Randall Avenue, described in the legal description attached as Exhibit A ("Site"), into thirty-two (32) single-family lots and one (1) common open space lot and a stormwater retention basin ("Project"); and

WHEREAS, in conjunction with the Project, the applicant has also submitted General Plan Amendment No. 2018-0002 to change the land use designation of the Site, from Residential 6 (2.1-6 du/acre) to Residential 12 (6.1-12.0 du/acre) (“GPA No. 2018-0002”); and

WHEREAS, in conjunction with the Project, the applicant has also submitted Zone Change No. 2017-0004 to change the zoning designation of the Site, from Single-Family Residential (R-1C) to Multi-Family Residential (R-3) ("ZC No. 2017-0004"); and

WHEREAS, the Project will create thirty-two (32) detached single-family lots in accordance with the development standards of the R-3 zone, one (1) common open space lot and a stormwater retention basin in accordance with the development standards of the R-3 zone; and

WHEREAS, in conjunction with the Project, the applicant will also develop one (1) detached single-family residence on each of the thirty-two (32) single-family lots on the Site; and

WHEREAS, the Project within the R-3 zone requires the approval of a tentative tract map, and the applicant has agreed to apply for a Tentative Tract Map No. 2017-0006, also referred to as Tentative Tract Map No. 20108, ("TTM No. 20108"), in accordance with the Subdivision Map Act (Government Code §§ 66410 et seq.); and

1 California Code of Regulations, Title 14, Section 15000 et. seq., and Government Code Section
2 65962.5(f) (Hazardous Waste and Substances Statement), the City reviewed an Initial Study
3 (Environmental Assessment Review No. 2017-0066) prepared by and determined that there is no
4 substantial evidence that the approval of the Project would result in a significant adverse effect
5 on the environment, provided appropriate mitigation measures are imposed on the Project; thus,
6 a Mitigated Negative Declaration was prepared and notice thereof was given in the manner
7 required by law; and

8 WHEREAS, a Notice of Intent to adopt the Mitigated Negative Declaration for the
9 Project was published in the San Bernardino Sun newspaper, and mailed to all property owners
10 within 300 feet of the Project Site, and a twenty (20) day public comment period was held from
11 October 24, 2018 to November 12, 2018; and

12 WHEREAS, The Planning Division received no public comment letters during the twenty
13 (20) day public comment period; and

14 WHEREAS, the City mailed public hearing notices for the proposed Project to all
15 property owners within 300 feet of the project site, and published the public hearing notice in the
16 San Bernardino Sun newspaper as required by State law; and

17 WHEREAS, on November 28, 2018, the Planning Commission of the City of Rialto
18 conducted a duly noticed public hearing, as required by law, on the Mitigated Negative
19 Declaration, GPA No. 2018-0002, ZC No. 2017-0004, and TTM No. 20108, took testimony, at
20 which time it received input from staff, the city attorney, and the Applicant; heard public
21 testimony; discussed the proposed GPA No. 2018-0002, ZC No. 2017-0004, and TTM No.
22 20108; and closed the public hearing; and

23 WHEREAS, all legal prerequisites to the adoption of this Resolution have occurred.

24 NOW, THEREFORE, BE IT RESOLVED by the Planning Commission of the City of
25 Rialto as follows:

26 SECTION 1: The Planning Commission hereby finds all of the above recitals to be true
27 and correct.
28

1 SECTION 2: The Initial Study and Mitigated Negative Declaration (Environmental
2 Assessment Review No. 2017-0066), Exhibit “B” hereto, prepared for the project concluded that
3 there are no impacts or less than significant impacts to aesthetics, agriculture and forestry
4 resources, air quality, biological resources, geology/soils, greenhouse gas emissions, hazards and
5 hazardous materials, hydrology/water quality, land use/planning, mineral resources,
6 population/housing, public services, recreation, transportation/traffic, tribal cultural resources,
7 and utilities and service systems. The Initial Study and Mitigated Negative Declaration also
8 identified that the Site did not have suitable habitat for any threatened or endangered species, and
9 therefore the proposed Project will have no individual or cumulative adverse impacts upon
10 resources, as defined in Section 711.2 of the State Fish and Game Code. The Initial Study and
11 Mitigated Negative Declaration further concluded that, after incorporation of the recommended
12 mitigation measures, the Project’s impacts on cultural resources, geology/soils, tribal cultural
13 resources, noise, and mandatory findings of significance in the community would also be less
14 than significant.

15 SECTION 3: The Planning Commission has independently reviewed and considered the
16 Initial Study and proposed Mitigated Negative Declaration, related studies, the public comments
17 upon it, and other evidence and finds that the Mitigated Negative Declaration was prepared in the
18 manner required by law, and there is no substantial evidence supporting a fair argument that the
19 Project would result in a significant adverse effect upon the environment, provided appropriate
20 mitigation measures are imposed.

21 SECTION 4: Furthermore, the Initial Study and Mitigated Negative Declaration further
22 concluded that, with the imposition of mitigation measures that address potential impacts upon
23 cultural resources, geology/soils, tribal cultural resources, noise, and mandatory findings of
24 significance in the community, and as set forth in the Mitigation Monitoring & Reporting
25 Program, Exhibit “C” hereto, which is attached hereto and incorporated herein by this reference,
26 the proposed Project’s potential significant impacts will be reduced below a level of significance.

27 SECTION 5: For the foregoing reasons and based on the information and findings
28 included in the Initial Study and Staff Report, the Planning Commission has determined that the

1 Project, as conditioned and mitigated, will not have a significant adverse impact on the
2 environment and also finds that the preparation of the Mitigated Negative Declaration attached
3 hereto complies with CEQA. Therefore, the Planning Commission recommends that the City
4 Council certify the Mitigated Negative Declaration, which is attached hereto as Exhibit "B" and
5 incorporated herein by this reference, making certain environmental findings to allow the
6 Project.

7 SECTION 6: The Chairman of the Planning Commission shall sign the passage and
8 adoption of this resolution and thereupon the same shall take effect and be in force.
