## **RESOLUTION NO. <u>19-XX</u>**

A RESOLUTION OF THE PLANNING COMMISSION OF THE CITY OF RIALTO, CALIFORNIA ADOPTING A MITIGATED NEGATIVE DECLARATION (ENVIRONMENTAL ASSESSMENT REVIEW NO. 2018-0024) FOR A PROJECT CONSISTING OF THE DEVELOPMENT OF A 99,999 SQUARE FOOT WAREHOUSE BUILDING ON 4.63 GROSS ACRES OF LAND (APNS: 0240-181-32 & -33) LOCATED ON THE NORTH SIDE OF BASE LINE ROAD APPROXIMATELY 315 FEET EAST OF PALMETTO AVENUE WITHIN THE EMPLOYMENT (EMP) ZONE OF THE RENAISSANCE SPECIFIC PLAN.

WHEREAS, the applicant, CDRE Holdings 11, LLC, proposes to construct a 99,999 square foot warehouse building ("Project") on 4.63 gross acres of land (APNs: 0240-181-32 & -33) located on the north side of Base Line Road approximately 315 feet east of Palmetto Avenue within the Employment (EMP) zone of the Renaissance Specific Plan ("Site"); and

WHEREAS, as part of the Project, the applicant has also submitted Conditional Development Permit No. 2018-0043 to allow up to a ten (10) percent increase in the maximum floor area ratio through the implementation of non-residential development incentives, as it relates to the Project ("CDP No. 2018-0043"); and

WHEREAS, pursuant to the provisions of the California Environmental Quality Act, Public Resources Code Sections 21000 et. seq. (" CEQA"), the State's CEQA Guidelines, California Code of Regulations, Title 14, Section 15000 et. seq., and Government Code Section 65962.5(f) (Hazardous Waste and Substances Statement), the City prepared an Initial Study (Environmental Assessment Review No. 2018-0024) and determined that there is no substantial evidence that the approval of the Project would result in a significant adverse effect on the environment, provided appropriate mitigation measures are imposed on the Project; thus, a Mitigated Negative Declaration was prepared and notice thereof was given in the manner required by law; and

WHEREAS, a Notice of Intent to adopt the Mitigated Negative Declaration for the Project was published in the San Bernardino Sun newspaper, and mailed to all property owners within 300

feet of the Project Site, and a twenty (20) day public comment period was held from October 31, 2 2018 to November 19, 2018; and

WHEREAS, one (1) comment letter was received from the South Coast Air Quality Management District (SCAQMD), which was submitted on November 14, 2018; and

WHEREAS, the comment letter from SCAQMD recommended the preparation of a Health Risk Assessment (HRA) to determine if the project will have a significant effect on the nearby residential uses, as it relates to the exposure of toxic air contaminants, such as diesel particulate matter from diesel fueled trucks visiting the site; and

WHEREAS, December 7, 2018, the Planning Division, in coordination with Urban Crossroads, provided SCAQMD a HRA prepared for the project, which concluded that toxic air contaminants generated by the project will not exceed any thresholds of significance established by SCAQMD; and

WHEREAS, the Planning Division did not receive any further comment from SCAQMD upon providing the HRA; and

WHEREAS, the City mailed public hearing notices for the proposed Project to all property owners within 300 feet of the project site, and published the public hearing notice in the San Bernardino Sun newspaper as required by State law; and

WHEREAS, on January 9, 2019, the Planning Commission of the City of Rialto conducted a duly noticed public hearing, as required by law, on the Mitigated Negative Declaration and CDP No. 2018-0043, took testimony, at which time it received input from staff, the city attorney, and the Applicant; heard public testimony; discussed the proposed Mitigated Negative Declaration and CDP No. 2018-0043; and closed the public hearing; and

WHEREAS, all legal prerequisites to the adoption of this Resolution have occurred.

NOW, THEREFORE, BE IT RESOLVED by the Planning Commission of the City of Rialto as follows:

SECTION 1: The Planning Commission hereby finds all of the above recitals to be true and correct.

SECTION 2: The Initial Study and Mitigated Negative Declaration (Environmental Assessment Review No. 2018-0024) prepared for the project concluded that even without mitigation, the Project's impacts on aesthetics, agricultural and forestry resources, air quality, geology and soils, greenhouse gas emissions, hazards and hazardous materials, hydrology and water quality, land use and planning, mineral resources, population and housing, public services, recreation, transportation and traffic, and utilities and service systems would be less than significant. The Initial Study and Mitigated Negative Declaration (EAR No. 2018-0024) also identified that the Site did not have suitable habitat for any threatened or endangered species, and therefore the proposed Project will have no individual or cumulative adverse impacts upon resources, as defined in Section 711. 2 of the State Fish and Game Code. The Initial Study and Mitigated Negative Declaration (EAR No. 2018-0024) further concluded that, after incorporation of the recommended mitigation measures, the Project's impacts on cultural resources, noise, and tribal resources would also be less than significant.

<u>SECTION 3:</u> The Planning Commission has independently reviewed and considered the Initial Study proposed Mitigated Negative Declaration, related studies, the public comments upon it, and other evidence and finds that the Mitigated Negative Declaration was prepared in the manner required by law, and there is no substantial evidence supporting a fair argument that the Project would result in a significant adverse effect upon the environment, provided appropriate mitigation measures are imposed.

<u>SECTION 4:</u> With the imposition of mitigation measures that address potential impacts upon biological resources and cultural resources in the community and as set forth in the Mitigation Monitoring Program, <u>Exhibit "B"</u> hereto, which is attached hereto and incorporated herein by this reference, the proposed project's potential significant impacts will be reduced below a level of significance.

<u>SECTION 5:</u> For the foregoing reasons and based on the information and findings included in the Initial Study and Staff Report, the Planning Commission has determined that the Project, as conditioned and mitigated, will not have a significant adverse impact on the environment and also finds that the preparation of the Mitigated Negative Declaration attached hereto complies with

3	making certain environmental findings to allow the Project, as well as the Mitigation Monitoring
4	and Reporting Program attached as Exhibit "B".

6	adoption of this resolution and thereupon the same shall take effect and be in force.
