## RESOLUTION NO.\_\_\_\_

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO, STATE OF CALIFORNIA, APPROVING PARCEL MAP 19639 FOR THE CONSOLIDATION OF SIX (6) PARCELS OF LAND INTO ONE (1) 24.34 ACRE PARCEL OF LAND TO FACILITATE THE DEVELOPMENT OF A 525,110 SQUARE FOOT WAREHOUSE BUILDING LOCATED AT THE NORTHEAST CORNER OF WILLOW AVENUE AND SANTA ANA AVENUE (APN'S 0258-041-04, -06, -12, -31, -33 & -34).

WHEREAS, IDIL Willow, LLC, a Delaware limited liability company, (the "Subdivider") applied for Tentative Parcel Map No. 19639 ("TPM 19639") to consolidate six (6) parcels of land (APN's: 0258-041-04, -06, -12, -31, -33, -34) into one (1) 24.34 acre parcel ("Project") located at the northeast corner of Willow Avenue and Santa Ana Avenue; and

WHEREAS, the City Council, at its meeting of June 13, 2017, approved TPM 19639 subject to conditions; and

**WHEREAS**, the Subdivider offers for dedication to the City for public use easements for street and public utilities purposes for Willow Avenue, Santa Ana Avenue, and Riverside Avenue as shown on Parcel Map 19639; and

WHEREAS, required public improvements have not been completed by the Subdivider as of the filing of Parcel Map 19639, and all required public improvements have been listed in an Improvement Certificate on the parcel map in accordance with Section 66411.1(a) of the California Government Code and shall be required to be completed in accordance with a Subdivision Improvement Agreement approved by and between the City and the Subdivider.

WHEREAS, the City Engineer has reviewed Parcel Map 19639 and has determined that the conditions of approval associated with TPM 19639 have been satisfied, that Parcel Map 19639 is in substantial conformance with TPM 19639, and that Parcel Map 19639 is ready for City Council approval.
