

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO, CALIFORNIA ORDERING THE ABATEMENT OF WEEDS ON VARIOUS PROPERTIES WITHIN THE CITY LIMITS, AND SETTING A PUBLIC HEARING FOR RULING ON ANY OBJECTIONS THERETO.

Section 4. All owners of the parcels of property set forth in Exhibit “A” are ordered to abate all weeds growing upon or in front of their property by May 1, 2019. If the weeds upon any parcel of property identified in Exhibit “A” are not destroyed or removed by May 1, 2019, a City contractor will begin to destroy and remove them from the parcels of property and the cost thereof shall become lien on each parcel of property set forth in Exhibit “A” from which the weeds were destroyed and removed.

1 **Section 5.** The City Clerk is hereby directed to mail written notice of the proposed abatement
2 and public hearing thereon to all persons owning the parcels of property described in Exhibit “A.” Said
3 notice shall be mailed at least 5 days prior to the time for hearing objections by the City Council.

4 **Section 6.** The notice mailed by the City Clerk shall comply with all provisions set forth in
5 Section 39567.1 of the California Government Code and shall be in substantially the same form as the
6 notices attached hereto as Exhibit “B” and Exhibit “C.”

7 **Section 7.** Any parcel of property not abated by the owner thereof by May 6, 2019, in
8 accordance with this Resolution shall be abated by the contractor selected by the City of Rialto, as directed
9 by and in a manner approved by the Fire Chief. All costs of such abatement will be the responsibility of
10 the property owner.

11 **Section 8.** The City Council shall hold a public hearing for the purpose of hearing any and all
12 objections to the proposed resolution for the removal of weeds, rubbish and refuse upon private property,
13 and dirt upon the parkways and sidewalks, and to impose the abatement cost therefore as a lien against
14 the parcels of property set forth in Exhibit “A” hereto at its regular Council Meeting on Tuesday, April 9,
15 2019, at 6:00 p.m. in the Council Chambers. Any property owner who fails to appear and object to the
16 order to abate the weeds upon each owner’s parcel of property shall waive the owner’s right to contest
17 this abatement order and the cost of the abatement.

18 **Section 9.** The contractor’s costs and a separate administrative fee of \$140.60 per parcel will
19 be charged each time that the weeds upon a parcel identified in Exhibit “A” is abated.

20 **Section 10.** Upon the conclusion of the Weed Abatement Program, all costs of abatement,
21 including the contractor’s costs and the administrative fees, shall be placed on the San Bernardino County
22 Property Tax Rolls for each parcel.
