3 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
4 RIALTO, CALIFORNIA, ADOPTING A LIST OF PROJECTS FOR  
5 FISCAL YEAR 2019/2020 FUNDED BY SB-1: THE ROAD REPAIR  
6 AND ACCOUNTABILITY ACT OF 2017.

7 WHEREAS, Senate Bill 1 (SB 1), the Road Repair and Accountability Act of 2017  
8 (Chapter 5, Statutes of 2017) was passed by the Legislature and Signed into law by the  
9 Governor in April 2017 to address the significant multi-modal transportation funding shortfalls  
10 statewide; and

11 WHEREAS, SB 1 includes accountability and transparency provisions that will ensure  
12 the residents of our City are aware of the projects proposed for funding in our community and  
13 which projects have been completed each fiscal year; and

14 WHEREAS, the City must adopt by resolution a list of projects proposed to receive  
15 fiscal year funding from the Road Maintenance and Rehabilitation Account (RMRA), created  
16 by SB 1, which must include a description and the location of each proposed project, a  
17 proposed schedule for the project's completion, and the estimated useful life of the  
18 improvement; and

19 WHEREAS, the City, will receive an estimated \$1,800,000 in RMRA funding in Fiscal  
20 Year 2019/2020 from SB 1; and

21 WHEREAS, this is the third year in which the City is receiving SB 1 funding and will  
22 enable the City to continue essential road maintenance and rehabilitation projects, safety  
23 improvements, repairing and replacing aging bridges, and increasing access and mobility  
24 options for the traveling public that would not have otherwise been possible without SB 1; and

25 WHEREAS, the City has undergone a robust public process to ensure public input into  
26 our community's transportation priorities; and

27 WHEREAS, the City used a Pavement Management System to develop the SB 1  
28 project list to ensure revenues are being used on the most high-priority and cost-effective  
projects that also meet the community's priorities for transportation investment; and

1       **WHEREAS**, the funding from SB 1 will help the City maintain and rehabilitate  
2 streets/roads throughout the City this year and into the future; and

3       **WHEREAS**, the 2018 California Statewide Local Streets and Roads Needs Assessment  
4 found that the City’s streets and roads are in an “at-risk” condition and this revenue will help  
5 us increase the overall quality of our road system and over the next decade will bring our  
6 streets and roads into a “good” condition; and

7       **WHEREAS**, the SB 1 project list and overall investment in our local streets and roads  
8 infrastructure with a focus on basic maintenance and safety, investing in complete streets  
9 infrastructure, and using cutting-edge technology, materials and practices, will have significant  
10 positive co-benefits statewide.

11       **NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY**  
12 **FIND, DETERMINE, AND RESOLVE AS FOLLOWS:**

13       **Section 1:** The foregoing recitals are true and correct.

14       **Section 2:** The list of proposed projects attached hereto as **Exhibit A** will be funded  
15 in part or solely with fiscal year 2019/2020 Road Maintenance and Rehabilitation Account  
16 revenues.

17       **Section 3:** The list of previously proposed and adopted projects attached hereto as  
18 **Exhibit B** may utilize fiscal year 2019/2020 Road Maintenance and Rehabilitation Account  
19 revenues in their delivery. With the relisting of these projects in the adopted fiscal year  
20 resolution, the City is reaffirming to the public and the State our intent to fund these projects  
21 with Road Maintenance and Rehabilitation Account revenues.
