## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO, CALIFORNIA, AMENDING ITS 2018-2019 FISCAL AUTHORIZING A RECRUITMENT INCENTIVE BUDGET **PROGRAM**

WHEREAS, the budget for fiscal year 2018-2019 of the City of Rialto has been adopted by this Council in its original form, and said budget will need to be amended at times to fulfill the goals of the City; and

WHEREAS, the City departments may not exceed their appropriations by character of expense, with character of expense being defined as personnel services, services and supplies, capital outlay, debt service and transfers, without the consent of the City Administrator; and

**WHEREAS**, the City Administrator may transfer appropriations, between departments and within their respective funds, as long as those appropriations do not exceed their fund total unless approved by Council; and

**WHEREAS**, the City of Rialto seeks to authorize the implementation of a Recruitment Incentive Program for the Rialto Police Department's newly hired lateral employees.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

Section 1: To approve the Recruitment Incentive Program in order to attract qualified and experienced law enforcement professionals and fill vacant positions within the Rialto Police Department; and

Authorize incentives for qualified lateral police officer new hires to receive Section 2: Recruitment Incentive Program incentives of \$5,000 to be paid within the initial pay period and \$5,000 to be payable within the first pay period, after the successful completion of the employee's probationary period; and

Section 3: Authorize incentives for qualified lateral non-sworn new hires to receive Recruitment Incentive Program incentives of \$2,500 to be paid within the initial pay period and \$2,500
