

RESOLUTION DECLARING THE INTENTION OF THE
COUNCIL OF THE CITY OF RIALTO TO INITIATE
ON ITS OWN MOTION PROCEEDINGS TO ANNEX
CERTAIN UNINHABITED TERRITORY.

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF RIALTO:

I. That the Council of the City of Rialto, for the reasons hereinafter mentioned, proposes to initiate on its own motion, as soon as it can legally do so, proceedings to annex to the City of Rialto all of the territory hereinafter described, as uninhabited territory, under provisions of the Annexation of Uninhabited Territory Act of 1939 as set forth in Sections 35300 to 35325, inclusive, of the Government Code of the State of California.

II. That the Council's reasons for proposing to initiate said annexation proceedings are as follows: The annexation of the hereinafter described territory will contribute to the orderly growth of the city, provide the proper control of street layout, drainage, sanitary sewer design, and insure the proper use of land in conformity with the overall general plan of the city.

III. That the territory which the Council proposes to annex is hereby identified as "Annexation No. 92" and consists of all that real property situate in the County of San Bernardino, State of California, described as follows:-

Being all of Lots 1 through 16 of Rialto Heights Subdivision as recorded in Map Book 18, Page 22, Records of San Bernardino County, California, and all of Lots 3 through 10 of Palmer Subdivision as recorded in Map Book 18, Page 72, Records of San Bernardino County, California, and portions of Sections 33 and 34, Township 1 North, Range 5 West, San Bernardino Base and Meridian, more particularly described as follows:-

Beginning at the Southeast corner of said Section 34, said corner

1 also being the centerline intersection of Cactus Avenue and Baseline
2 Road, said corner also being on the boundary of the City of Rialto;
3 thence Westerly along the South line of said Section 34, said line
4 also being the centerline of said Baseline Road, said line also
5 being on the boundary of the City of Rialto; to an intersection
6 with the centerline of Wadleigh Street, 60 feet wide; thence
7 Northerly along the centerline of said Wadleigh Street, said center-
8 line also being on the boundary of the City of Rialto, to the North
9 line of the South 1/2 of Section 34; thence Westerly along said
10 North line of the South 1/2 of Section 34, said line also being on
11 the boundary of the City of Rialto, to the West line of said
12 Section 34; thence continuing Westerly along the North line of the
13 South 1/2 of said Section 33, said line also being on the boundary
14 of the City of Rialto; to the West line of the East 1/2 of said
15 Section 33; thence Northerly along said West line of the East 1/2
16 of Section 33, to the North line of said Section 33, said North
17 line also being the centerline of Highland Avenue; thence Easterly
18 along said North line of Section 33, said North line also being
19 the centerline of Highland Avenue, to the Northeast corner thereof;
20 thence continuing Easterly along the North line of said Section 34,
21 said line also being the centerline of Highland Avenue, to the
22 West line of the East 1/2 of the Northeast 1/4 of said Section 34;
23 thence Southerly along said West line of the East 1/2 of the
24 Northeast 1/4 of Section 34 to the North line of the South 1/2 of
25 said Section 34; thence Easterly along said North line of the
26 South 1/2 of Section 34 to a point on the East line of said Section
27 34, said point also being on the centerline of said Cactus Avenue,
28 said point also being on the boundary of the City of Rialto;

1 thence Southerly along said East line of Section 34, said East line
2 also being the centerline of said Cactus Avenue, said East line
3 also being on the boundary of the City of Rialto, to the point of
4 beginning.

6 IV. That the City Planning Director of the City of Rialto is
7 hereby directed to file with the Local Agency Formation Commission,
8 this proposal to initiate proceedings to annex the hereinabove
9 described uninhabited territory to the City of Rialto.


