1       **WHEREAS**, the Business License Tax Summary attached hereto as Attachment “A” and  
2 included herein by this reference was modified to reflect the new \$0.075 per square foot rate for  
3 calculation of the business license tax for distribution facilities under the optional methodology.

4       **WHEREAS**, the Business License Tax Summary attached hereto as Attachment “B” and  
5 included herein by this reference has been modified to correct a clerical error within the Truck  
6 Deliveries classification fee schedule. The correction will modify the gross receipt base amount of  
7 \$500,000 to \$300,000, and the associated tax amount of \$100 to \$79 as previously established in  
8 Resolution 5280.

9       **NOW, THEREFORE**, the City Council of the City of Rialto does hereby resolve as follows:

10       **Section 1.**     The City Council hereby rescinds Resolution No. 7044 and adopts the  
11 Business License Tax Summary attached hereto as Attachment “B” in its entirety, which shall  
12 supersede all previously adopted fee schedules for business licenses.

13       **Section 2.**     Severability. The provisions of this Ordinance are severable and if any  
14 provision, clause, sentence, word or part thereof is held illegal, invalid, unconstitutional, or  
15 inapplicable to any person or circumstances, such illegality, invalidity, unconstitutionality, or  
16 inapplicability shall not affect or impair any of the remaining provisions, clauses, sentences, sections,  
17 words or parts thereof of the ordinance or their applicability to other persons or circumstances.

18       **Section 3.**     Effective Date. This Resolution shall take effect and be enforced upon its  
19 adoption.
