Easton Street Sidewalk Improvements	City of Rialto Public Works Department	The project proposes to construct sidewalk, Americans with Disabilities Act (ADA) accessible curb ramps, relocation of planter areas, relocation of block walls and installation of retaining walls along Easton Street from North Sage Court to Acacia Avenue in the City of Rialto. ADA compliant sidewalk will be added on the north and south side of Easton Street from Acacia Avenue to 600 feet to the west. Truncated domes will be added at all curb ramps installed. The proposed project facilitates ADA Accessibility to Frisbie Park at Acacia Avenue with the City installing ADA Accessible improvements from the east side of Acacia Avenue to provide connectivity to Frisbie Park under the Frisbie Park Expansion Project beginning construction in 2019. CDBG Funds will be used to implement a design for the subject improvements, construction cost, permitting, management and inspection related to the project.	LMA	\$0	\$550,000	\$0
Community Center Buildings & Tenant Improvements	City of Rialto Public Works Department	The Public Works Department proposes to renovate the Community Center Buildings/Wings 300,400, and 500 wings located at 214 N. Palm Avenue to provide upgraded facilities which meet Americans with Disabilities Act (ADA) compliance standards. Community patrons in wheelchairs currently using the facility find it very difficult and unsafe and at times impossible to enter and exit buildings.
