## RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO, CALIFORNIA, GIVING PRELIMINARY APPROVAL OF THE ENGINEERS REPORT FOR STREET LIGHT MAINTENANCE DISTRICT NO. 1, AND THE LEVY AND COLLECTION OF ANNUAL ASSESSMENTS RELATED THERETO FOR FISCAL YEAR 2019/2020.

WHEREAS, the City Council of the City of Rialto, California, (hereinafter the "City Council"), has by previous Resolution established the Street Light Maintenance District No. 1, pursuant to the provisions of the Landscaping and Lighting Act of 1972, Part 2 of Division 15 of the Streets and Highways Code of the State of California, beginning with §22500 (hereafter referred to as the "Act"), that provides for the levy and collection of assessments by the City of Rialto to pay for the maintenance and services of improvements and all appurtenant facilities and operations related thereto; and

**WHEREAS**, Street Light Maintenance District No. 1 includes an existing street light and electrical system, and publicly maintained street trees, and appurtenant facilities and improvements within the incorporated boundaries of the City of Rialto; and

**WHEREAS**, the Act provides for the levy and collection of assessments by the County of San Bernardino for the City of Rialto to pay costs for the maintenance and services of all improvements and facilities related thereto; and

WHEREAS, the City Engineer has prepared an Engineer's Report (hereafter referred to as the "Report") in accordance with the Act, and in accordance with the requirements of Articles XIIIC and XIIID of the California Constitution as enacted by the passage of Proposition 218, also referred to as "The Right to Vote on Taxes Act," as approved by the voters of the State of California on November 5, 1996.

WHEREAS, there has now been presented to the City Council the Report for Street Light Maintenance District No. 1 for Fiscal Year 2019/2020; and

WHEREAS, the City Council has carefully examined and reviewed the Report as presented and is preliminarily satisfied with each and all of the budget items and documents as set forth therein, and is preliminarily satisfied that the proposed annual assessments have been spread in accordance with the special benefits properties within Street Light Maintenance District No. 1 will receive from the improvements, operation, maintenance and services to be performed as part of Street Light Maintenance District No. 1, as set forth in said Report.

## NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

**Section 1:** The preceding recitals are all true and correct.

**Section 2:** The Report, as presented, consists of the following:

- 1) A description of Street Light Maintenance District No. 1 and its improvements.
- 2) A Method of Apportionment that outlines the special benefit conferred on properties within Street Light Maintenance District No. 1 from the improvements; and the calculations used to establish each parcel's proportional special benefit assessment for Fiscal Year 2019/2020.
- 3) An annual budget that outlines the costs and expenses to service, and maintain the improvements, including incidental expenses, as authorized by the Act.
- 4) An Assessment Diagram that identifies the lots, parcels and properties included within the boundaries of Street Light Maintenance District No. 1.
- 5) An Assessment Roll containing each of the Assessor Parcel Numbers that comprise Street Light Maintenance District No. 1, and the proportional maximum assessment for Fiscal Year 2019/2020.

**Section 3:** The Report is hereby approved on a preliminary basis (as submitted or amended), and ordered to be filed in the Office of the City Clerk as a permanent record and to remain open to public inspection.

**Section 4:** The proposed assessments for Fiscal Year 2019/2020 are less than or equal to the maximum assessment amounts previously approved by property owner petition

1	or balloting, in accordance with the provisions of the California Constitution Article XIIID
2	(Proposition 218).
3	Section 5: The City Clerk shall certify to the passage and adoption of this
4	Resolution, and the minutes of this meeting shall so reflect the presentation of the Report for
5	Street Light Maintenance District No. 1.
