15 RIALTO DOES HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

16 Section 1: That the Rialto Utility Authority of the City of Rialto does continue the 2018-19  
17 annual budget in full force and effect until August 30, 2019 or adoption of the Fiscal Year 2019-20
