A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO, CALIFORNIA, ADOPTING THE FISCAL YEAR 2019/2020 BUDGET

WHEREAS, the proposed budget for fiscal year 2019/2020 of the City of Rialto has been submitted to this Council, and said budget has been considered and, is in form and substance satisfactory to this Council; and

WHEREAS, the City departments may not exceed their appropriations by character of expense, with character of expense being defined as personnel services, services and supplies, capital outlay, debt service and transfers, without the consent of the City Administrator; and

WHEREAS, the City Administrator may transfer appropriations, between departments and within their respective funds, as long as those appropriations do not exceed their fund total unless approved by Council; and

WHEREAS, the City Administrator is authorized to make changes to the Adopted Budget only to accommodate actual fund balance as determined at year end and any technical balancing adjustments to appropriations, revenue, and available reserves; and

WHEREAS, the City Departments may not hire in excess of the approved number of positions in job classification as indicated by the budget detail without the consent of the City Council; and

WHEREAS, it is the intent to ensure that maximum efficiency and savings are realized within each department of the City, all personnel additions including temporary staffing shall require approval by the City Administrator; and

WHEREAS, the inter-fund borrowings arising from deficit spending in any fund shall require City Council action to provide for appropriate repayment terms and conditions; and

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

Section 1: That the budget for the City of Rialto for the fiscal year 2019/2020 is hereby approved and adopted in the form on file with the City Clerk.

1	Section 2: That specific appropriations for each fund and each operating department are
2	hereby made as set forth in the budget, for fiscal year 2019/2020, which is incorporated herein by this
3	reference.
