NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS: Section 1: That the maximum limit for 2019/2020 fiscal year's appropriations from 'Proceeds of Taxes" shall be \$81,762,887 and actual appropriations from 'Proceeds of Taxes" submitted in Fiscal Year 2018/2019 for the City of Rialto shall be \$59,552,476 based on attached calculations; and That the City of Rialto reserves the right to recalculate said limitation at a future Section 2: time. /////
