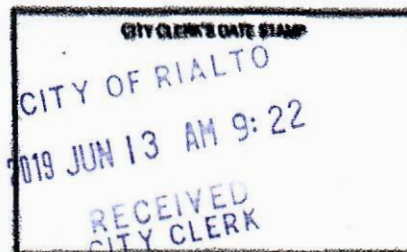

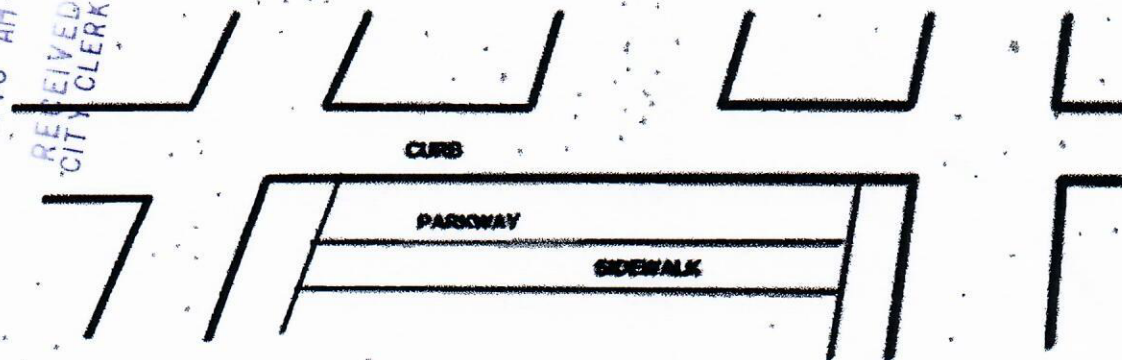

On the evening of Monday April 29th, 2019 my riding lawn mower was stolen from outside my residence at [REDACTED] Rialto 92376. This act was a deliberate and intimidating act of members of the San Bernardino County Sheriff's Department's Aerial Division and others associated with a regional air task force, who jointly work in a reserve capacity with the US Military specifically the Air Force. Since running for City Council for the City of Rialto in 2014 and after service with the California State Legislature in the role of District Director for the 48th Assembly District. I have been harasssed, intimidated, and stalked, even after complying by not actively campaigning after being told to remove my name from the ballot, (it was too late for my name to be removed).

Numerous 911 calls were made by me as the San Bernardino County Sheriff's Aviation division would circle my home for hours and follow me around in plain sight as some sort of a training exercise. The calls stopped when I was confidentiality informed that ex-military members within the ~~Rialto Police Department~~ working in reserve or other auxiliary divisions had been instructed to surveill and harass me. Drones were placed adjacent to my residence and whether it was to a funeral, work, visiting sick relatives, or church with my family they would stalk me and my family everywhere we went.

Of course the abuse inflicted caused lasting trauma on myself and family, and my trust in law enforcement has been forever altered. The feelings of fear, humiliation, and distrust of government resulting from bad police encounters with the Rialto PD will continue. The feelings are exacerbated when realizing police officers were using their connection with the military to carry out this conduct.

The harassment continued on a few times being pulled over after surveillance planes and helicopters did there daily intimidation fly arounds, but on April 29th it rose to the level of members actually trying to find a token to steal and celebrate. The lawnmower was subsequently found on Craigslist, and after investigating the number and was found to be highly associated with March Air Force Base. It was a riding lawn mower given to me from my father-in-law for an artificial lawn business. The mower was to be used to remove existing lawn. The value and of the lawn mower is \$1500 and loss revenue is put at \$75000.

This is not the first time the level of criminality escalated. Last year in March of 2018 funds were being systematically debited from my checking account. After reporting the issue to my card holder all funds were refunded and they were also confused after learning it was coming from an Air Force base in Georgia.

The factors and basis for this complaint are simply police misconduct. Corruption being the primary mitigating issue with ties to those current or formerly on the board of the Rialto City Council and potential contracts, appointments, and other interests. In this particular case it boiled down to racism, cruelty and meanness.
