**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
RIALTO TO APPROVING THE COMMITMENT OF FUND
BALANCE PURSUANT TO GASB 54**

WHEREAS, the Governmental Accounting Standards Board (GASB) has issued its Statements No. 54, Fund Balance Reporting and Governmental Fund Type Definitions, with the intent of improving financial reporting by providing fund balance categories that will be more easily understood; and

WHEREAS, the City Council may commit fund balance amounts for specific purposes by taking formal action, and the committed amounts cannot be used for any other purpose unless the City Council removes and changes the specific use through the same formal action taken to establish the commitment; and

WHEREAS, the City Council deems it appropriate that the current and prior years' commitments of fund balances be released; and

WHEREAS, the City Council deems it appropriate that a commitment of \$26,701,114 of the General Fund unassigned fund balance be established for Reserve for the following projects in the following amounts: Rialto Utility Authority Transfer of Colton Basin Litigation Settlement for \$3,000,000, Fire Station 205 for \$5,000,000, Community Choice Aggregation for \$118,060, Airport Contingent Liability for \$4,511,394, Advances to Other Funds for \$1,300,000, Inventory of \$52,184, Prepaid Expenses of \$142,766, the Rialto Data Analytics, Logistics, Business Acceleration and Training Center of \$2,086,860, General Fund Capital Outlay of \$4,905,660, One Time FY2019 Carryforward of \$594,555, Joe Baca Sr./ David Turch Park of \$4,689,635, Construction Loan for Renaissance East of \$300,000; and

WHEREAS, the General Fund fund balance will be adjusted for final fund balance at the end of the fiscal year, the commitment of fund balance to Joe Baca Sr./David Turch Park will be adjusted to reflect final fund balance; and

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES
HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:**

1 **Section 1:** The City Council establishes and approves the release of all prior years’
2 commitments of unassigned fund balance of the General Fund to the unassigned category of fund
3 balance as specified in the approved budget for 2019/2020.

4 **Section 2:** The City Council establishes and approves the commitment of \$26,701,114 of the
5 unassigned fund balance of the General Fund to the assigned category of fund balance.\\
