#### 1. PROBLEM STATEMENT

The Rialto Police Department's Traffic division is currently staffed by a Sergeant, a Corporal, four motors and two nighttime DUI Enforcement/Accident Investigation (DUI/AI) officers. The six Traffic enforcement officers cover our City (28 sq miles) from 0630 to 0430 hrs, six days a week with Sundays being patrolled by only one motor from 0630-1630 hrs. Generally speaking, after the weekday Motors finish up their dayshifts at 1600 hrs, there is one nighttime Traffic officer working 1600-0430, six days a week to cover the entire City in regards to enforcement, DUIs, and collision investigations. When a nighttime Traffic officer is sick, on vacation, at court or in school, there are no other traffic personnel to cover the absence which causes our depleted patrol shifts to shoulder all of the traffic duties and responsibilities.

With a population of approximately 106k, the City of Rialto falls into the category of the U.S. jurisdictional population (JP) of 100-200K. Although the national average number of officers per 10k population is 15.9, Rialto PD has only 9.1 officers per capita. To increase the number of officers on the street, the City has continuous openings for lateral Police Officers and we are currently recruiting new officers but because of a litany of reasons, we continue to lose trained and tenured officers to other agencies. Due to our hiring and retention issues as well as our budget constraints, the time line to add more personnel to our Traffic and Patrol division is unknown.

According to our "OTS Collision Rankings" within the 58 other agencies in our category when comparing 2016 to 2015 in collisions involving fatal/injuries we ranked #29 up from #24 in 2015; DUI crashes #19 up from #2; DUIs <21 #10 up from #5; DUIs 21-34 #10 up from #5; total pedestrian crashes we ranked #31 up from #16, peds <15 #20 up from #1, and peds 65+ #55 up from #40; speed collisions remained the same at #41; nighttime collisions we ranked #18 up from #6; hit and runs #30 up from #19; and 2016 DUI arrests we ranked #51 up from #49 in 2015. When reviewing these improvements in a vacuum, it appears that we've done a good job knocking down the number of collisions and raising our DUI arrests as compared to the previous year. But when compared to Fontana PD which is only twice our size but has a Traffic Division that is almost three times larger than Rialto's Traffic Division, there is a large gap between rankings. Our department's composite ranking is 22/58 whereas Fontana has a ranking of 38/58. Due to our stellar history with OTS, our out-of-the-box traffic safety mentality, and our consistent improvement, this large disparity can only be explained by our lack of non-OTS funded manpower which ultimately has a negative effect on the crash rates in every category.

The Rialto Police Department is budgeted for 110 sworn officers but currently has only 96 sworn officers; down from 105 in 2017. Of those 96 sworn officers only 36 officers work uniformed patrol. These 36 patrol officers are further broken down into five teams of 7-8 officers that work a 12 ½ hour shift (two shifts a day). On any given 24 hour period, these 14-16 police officers handle almost (300) calls for service each day. Currently with the aforementioned heavy work load and manpower shortages of both the Traffic and Patrol officers, it is nearly impossible to conduct proactive traffic enforcement as the lone tool to lowering the number of collisions within Rialto.

- The department will develop operational plans to implement the "best practice" strategies outlined in the objectives section.
- All training needed to implement the program should be conducted this quarter.
- All grant related purchases needed to implement the program should be made this quarter.
- In order to develop/maintain the "Hot Sheets," research will be conducted to identify the "worst of the worst" repeat DUI offenders with a suspended or revoked license as a result of DUI convictions.
