**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF  
RIALTO, CALIFORNIA, AMENDING SECTION 2.02.010 OF THE  
RIALTO MUNICIPAL CODE TO AMEND THE START TIME OF  
CITY COUNCIL MEETINGS TO SIX THIRTY P.M.**

WHEREAS, the Rialto Municipal Code, at Section 2.20.010 provides that the regular meetings of the City Council on the second and fourth Tuesdays of the month are to be held at 6:00 p.m. following closed sessions;

WHEREAS, the City Council has found that closed session discussions often take longer than the hour allotted before the regular start time for the regular City Council meetings;

WHEREAS, to avoid any delay in the commencement of the City Council meetings and reduce the instances where the Council needs to recess back into closed session after the open session, the Council is desirous of confirming the start time for closed session at 5:00 p.m., but amending the start time for City Council meetings to begin at 6:30 p.m., as provided in this Ordinance.

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO FINDS AND ORDAINS AS FOLLOWS:

**Section 1.** The above recitals are all true and correct and are hereby adopted as findings.

**Section 2.** The Rialto Municipal Code, at Subsections 2.02.010, entitled "Meetings – Time" shall be amended in its entirety to read as follows:

"2.02.010 - Meetings—Time.

Regular meetings of the city council are held on the second and fourth Tuesday of each month at six thirty (6:30) p.m. Closed session may begin at five (5:00) p.m. before the regular city council meetings as provided in the agendas for the meetings."

**Section 3.** The City Clerk shall certify to the adoption of this Ordinance, and cause the same to be published in the local newspaper, and the same shall take effect thirty (30) days after its date of adoption:
