

**AMENDMENT NO. 4 TO  
EXCLUSIVE RIGHT TO NEGOTIATE AGREEMENT**

This Amendment No. 4 (“Amendment”) to that certain Exclusive Right to Negotiate Agreement (“Agreement”) is made this 10<sup>th</sup> day of September 2019 by and between the City of Rialto, a municipal corporation (“City”), and NewMark Merrill Companies, LLC and/or its approved assignee, (“Developer”), pursuant to the following facts:

### **RECITALS**

**WHEREAS**, City and Developer did enter into the Agreement dated as of June 27, 2017; Amendment No. 1 to the Agreement on January 9, 2018 (“Amendment No. 1”); Amendment No. 2 on July 10, 2018 (“Amendment No. 2”); and, Amendment No. 3 on February 12, 2019 (“Amendment No. 3”)

**WHEREAS**, the parties have commenced negotiations as provided for in the Agreement; and

**WHEREAS**, the parties have mutually concluded that it is desirable for them to amend the term of the Agreement to provide additional time to complete their negotiations of a Disposition and Development Agreement for the development of commercial and retail uses on approximately 15.5 acres of property located on Riverside Avenue frontage, between Valley Boulevard and San Bernardino Avenue in the City of Rialto.

**NOW, THEREFORE**, City and Developer do hereby agree to amend the Agreement as follows:

Section One:      Section 3.5 (i) of the Agreement is amended to read as follows:

“3.5 (i)    On December 31, 2019 unless mutually extended by the parties prior to December 31, 2019.”

Section Two:      All other terms, conditions, clauses, phrases, covenants and promises contained in the Agreement and not modified herein shall remain in full force and effect notwithstanding this Amendment.

**WHEREFORE**, the parties have executed this Amendment No. 4, effective September 10, 2019.
