3 **A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF**
4 **RIALTO, CALIFORNIA, ADOPTING FIVE-YEAR CAPITAL**
5 **IMPROVEMENT PLAN, THE EXPENDITURE STRATEGY FOR**
6 **MEASURE I FUNDS.**

7 **WHEREAS**, San Bernardino County voters approved passage of Measure I in
8 November 2004, authorizing the San Bernardino County Transportation Authority to impose a
9 one-half of one percent retail transactions and use tax applicable in the incorporated and
10 unincorporated territory of the County of San Bernardino; and

11 **WHEREAS**, revenue from the tax can only be used for transportation improvement and
12 traffic management programs authorized in the Expenditure Plan set forth in Ordinance No.
13 89-1 and Ordinance No. 04-01 of the Authority; and

15 **WHEREAS**, the Measure I 2010-2040 Strategic Plan (Plan) defines the policy
16 framework for delivery of project and programs referenced in the Measure. The Plan requires
17 each local jurisdiction applying for revenue from the Local Street Program to annually adopt
18 and update a Five-Year Capital Improvement Plan; and

20 **WHEREAS**, the Expenditure Plan of the Ordinances also require that each local
21 jurisdiction annually adopt and update its Capital Improvement Plan.

23 **NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY**
24 **FIND, DETERMINE, AND RESOLVE AS FOLLOWS:**

26 **Section 1:** That the City of Rialto hereby adopts the Measure I Five Year Capital
27 Improvement Plan and the Expenditure Strategy as submitted to the City Council with its
28 adoption of this resolution, a copy of which are attached hereto as **Exhibit A** and **B**.
