RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO, STATE OF CALIFORNIA, AUTHORIZING THE FILING CERTAIN LIENS AGAINST PROPERTIES DELINQUENT REFUSE ACCOUNTS THE WITH BERNARDINO COUNTY AUDITOR CONTROLLER-RECORDER

WHEREAS, the City of Rialto, through a franchise agreement with Burrtec Waste Industries, provides for refuse collection services to property owners within the City pursuant to Rialto Municipal Code Chapter 8.08; and,

WHEREAS, each owner of such property is liable to pay for the cost of such refuse collection services pursuant to Rialto Municipal Code Chapter 8.08.140(C); and,

11 WHEREAS, each property owner listed on the attached Exhibit A has been billed for refuse service and is delinquent in the payment of such bill for refuse collection by ninety (90) 12 days or more; and, 13

14 WHEREAS, each property owner listed on the attached Exhibit A was mailed a notice 15 of the City's intent to place a lien on its property from which refuse was collected twenty-one 16 (21) days prior to the public hearing scheduled for December 10, 2019, that the notice 17 advised each property owner of said public hearing wherein the Rialto City Council will consider the imposition of such a lien on the owner's property and hear protests thereto, and 18 19 advised each property owner of their right to appear at the public hearing to protest the imposition of such a lien on the owner's property. The property totals and corresponding 20 dollar amounts may change in the event that the property owners pay the owed amount prior 21 22 to the lien being filed with the San Bernardino County Recorder's Office; and,

WHEREAS, the public hearing was held before the Rialto City Council on December 10, 2019 at which the City Council considered the imposition of liens on property for the cost of the refuse collection service provided and administrative costs and heard all protests thereto. 26
