WHEREAS, City of Rialto recognizes an intrinsic community benefit of providing for additional recreational activities and miscellaneous special events; and

WHEREAS, the city of Rialto has a coordinated group of city staff who work together as the City's Special Events Committee to manage requests for special events who can answer questions from the public about putting on an event in Rialto such as street closures, park use, off-duty police officers, and insurance requirements; and

WHEREAS, the proposed new policies and procedures will not significantly alter the way the City's facilities and athletic fields are allocated; and

WHEREAS, the Rialto Special Events Policy and Fee Schedule document will serve as a

reference for staff and potential users during the application process.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RIALTO, CALIFORNIA AS FOLLOWS:

1	Section 1. That the above recitals are true and correct.
2	Section 2. The City Council has considered Special Events Policy and Fee Schedule and
3	hereby finds that each event serves the legitimate public purpose(s) stated therein. As such, the City
4	Council hereby approves the Special Events Policy and Fee Schedule as listed in Exhibit "B," The City
5	Council further directs that the information provided about such events appropriately designate the City
6	of Rialto as the host, a participant or sponsor of such event, as appropriate.
7	Section 3. That the City Clerk shall certify to the adoption of this Resolution
