A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO, ACCEPTING THE SAN BERNARDINO COUNTY TRANSPORTATION AUTHORITY (SBCTA) TRANSPORTATION DEVELOPMENT ACT ARTICLE 3 GRANTS IN THE TOTAL AMOUNT OF \$240,432.

WHEREAS, in August 1999, the SBCTA Board approved a policy that 80% of the Transportation Development Act (TDA) Article 3 funds would be made available for projects that implement or improve bicycle and pedestrian facilities.

WHEREAS, the total amount of revenues available for award on the call for projects is \$2.694.827.

WHEREAS, the allocation of funds will remain available for no more than four full years after Board approval, with an additional two-year extension. The Board has set the initial period of time for completion of the Easton Sidewalk Improvements to comply with TDA provision to be completed by December 31, 2022.

WHEREAS, the city of Rialto match in the amount of \$275,540 is funded through the City of Rialto Local Measure I funds.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

Section 1: Accept the Transportation Development Act (TDA) Article 3 funds for projects that implement or improve bicycle and pedestrian facilities in the amount of \$226,000 for the Easton Sidewalk Improvements Project.

<u>Section 2:</u> Accept the Transportation Development Act (TDA) Article 3 funds for projects that implement accessibility improvements at transit stops in the amount of \$14,432 for the City of Rialto Bus Stops project.
