3 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
4 RIALTO, ACCEPTING THE SAN BERNARDINO COUNTY
5 TRANSPORTATION AUTHORITY (SBCTA) TRANSPORTATION
6 DEVELOPMENT ACT ARTICLE 3 GRANTS IN THE TOTAL
7 AMOUNT OF \$240,432.

8 WHEREAS, in August 1999, the SBCTA Board approved a policy that 80% of the
9 Transportation Development Act (TDA) Article 3 funds would be made available for projects
10 that implement or improve bicycle and pedestrian facilities.

11 WHEREAS, the total amount of revenues available for award on the call for projects is
12 \$2,694,827.

13 WHEREAS, the allocation of funds will remain available for no more than four full
14 years after Board approval, with an additional two-year extension. The Board has set the
15 initial period of time for completion of the Easton Sidewalk Improvements to comply with TDA
16 provision to be completed by December 31, 2022.

17 WHEREAS, the city of Rialto match in the amount of \$275,540 is funded through the
18 City of Rialto Local Measure I funds.

19 NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES
20 HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

21 Section 1: Accept the Transportation Development Act (TDA) Article 3 funds for
22 projects that implement or improve bicycle and pedestrian facilities in the amount of
23 \$226,000 for the Easton Sidewalk Improvements Project.

24 Section 2: Accept the Transportation Development Act (TDA) Article 3 funds for
25 projects that implement accessibility improvements at transit stops in the amount of \$14,432
26 for the City of Rialto Bus Stops project.
