A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO, STATE OF CALIFORNIA, APPROVING PARCEL MAP 19942 FOR THE CONSOLIDATION OF THREE (3) PARCELS OF LAND INTO ONE (1) PARCEL OF LAND TO FACILITATE THE DEVELOPMENT OF A 188,712 SQUARE FOOT INDUSTRIAL WAREHOUSE BUILDING LOCATED AT THE SOUTHWEST CORNER OF ALDER AVENUE AND WALNUT AVENUE (APNS: 0240-201-31, -60, AND -02).

WHEREAS, Pacific Industrial, LLC, (the "Subdivider") applied for Tentative Parcel Map 19942 ("TPM 19942") to consolidate three (3) parcels of land (APN's: 0240-201-31, -60, and -02) into one (1) parcel ("Project") located at the southwest corner of Alder Avenue and Walnut Avenue; and

WHEREAS, the City Planning Commission, at its meeting of November 28, 2018, approved TPM 19942 subject to conditions; and

WHEREAS, the Subdivider offers for dedication to the City for public use easements for street and public utilities purposes along Alder Avenue and Walnut Avenue as shown on Parcel Map 19942; and

WHEREAS, required public improvements have not been completed by the Subdivider as of the filing of Parcel Map 19942, and all required public improvements have been listed in an Improvement Certificate on the parcel map in accordance with Section 66411.1(a) of the California Government Code and shall be required to be completed in accordance with a Subdivision Improvement Agreement approved by and between the City and the Subdivider.

WHEREAS, the City Engineer has reviewed Parcel Map 19942 and has determined that the conditions of approval associated with TPM 19942 have been satisfied, that Parcel Map 19942 is in substantial conformance with TPM 19942, and that Parcel Map 19942 is ready for City Council approval.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

Section 1: Parcel Map 19942 is in substantial conformance with the approved TPM 19942.

Section 2: Requisite conditions associated with TPM 19942 have been satisfied.

Section 3: Parcel Map 19942 is in conformance with the General Plan.

<u>Section 4:</u> Parcel Map 19942 conforms to all applicable requirements of the Subdivision Map Act of the State of California.

<u>Section 5:</u> In accordance with Section 66477.1 of the California Government Code, the offers of dedication to the public on Parcel Map 19942 shall be accepted by the City Clerk, subject to improvement, who shall certify acceptance by signature on the map thereof.

<u>Section 6:</u> Parcel Map 19942 is hereby approved, subject to the terms of the Subdivision Improvement Agreement approved concurrently herewith, for the purposes therein defined.
