3	CALIFORNIA, AMENDING SECTION 17.20.070 OF THE RIALTO MUNICIPAL CODE RELATED TO THE AUTHORITY TO RELEASE SUPPLYISION IMPROVEMENT SECURITIES		
4	SUBDIVISION IMPROVEMENT SECURITIES		
5	WHEREAS, Section 17.20.070 provides for the release by the City of security instruments		
6	for public improvements completed as part of the development of a subdivision; and		
7	WHEREAS, pursuant to Section 66499.7(j) of the Government Code, the City Council may		
8	authorize any public official or employee to release or reduce the security required for such		
9	improvements in accordance with the requirements of state law and any rules that the City Council		
10	may prescribe; and		
11	WHEREAS, the City wishes to authorize the Public Works Director/City Engineer to release		
12	and reduce the security instruments required for public improvements.		
13 14	AND ORDAÍNS AS FOLLOWS:		
15	SECTION 1. The recitals set forth above are all true and correct and incorporated herein.		
16	SECTION 2. Section 17.20.070 of the Rialto Municipal Code is hereby amended to read in		
17	full as follows (additions in <i>bold italics</i> ; deletions in strikethrough):

19	manner:		
20	A. Security given for faithful performance of any act or agreement shall be		
21	released upon the final completion and acceptance of the act or work.		
22	B. Security given to secure payment to the contractor, his/her subcontractors		
23	and to persons furnishing labor, materials or equipment, may shall, after		
24	passage of the time within which claims of lien are required to be		
25	recorded pursuant to Section 8410 et seq. of the Civil Code (or any		
26	successor statute) and after acceptance of the work <mark>six months after the</mark>		
27	completion and acceptance of the act or work , be reduced to an amount		
28	equal to the amount of all claims therefore filed and of which notice has		

1	been given to the legislative body, plus an amount reasonably determined			
2	by the director of community services to be required to assure the			
3	performance of any other obligations secured thereby. The balance of the			
4	security shall be released upon the settlement of all such claims and			
5	obligations for which the security was given. If no claims have been			
6	recorded within the time stated above, the security shall be released in			
7	full.			
8	C. No security given for the guaranty or warranty of work shall be released			
9	until the expiration of the period thereof.			
10	D. The public works director/city engineer is authorized accept the			
11	improvements and to reduce or release security under this section in			
12	accordance with the requirements of state law and any policies that may			
13	be established by the city council."			
14	<u>SECTION 3.</u> If any provision of this Ordinance is held invalid, such invalidity shall not			
15	5 affect the remaining provisions of this Ordinance, which shall remain in effect absent the provision			
16	6 held to be invalid, and to this end, the provisions of this Ordinance are declared to be severable.			
17	SECTION 4. The City Clerk shall certify to the adoption of this Ordinance and cause the			
18	8 same to be published in the local newspaper or posted as required, and the same shall take effect			
19	by thirty (30) days after its date of adoption.
