AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF RIALTO, CALIFORNIA, ADDING SECTIONS TO CHAPTER 18.66 (CONDITIONAL DEVELOPMENT PERMITS) AND AMENDING SECTION 18.38.020 OF THE RIALTO MUNICIPAL CODE TO **REOUIRE** THE **APPROVAL OF CONDITIONAL DEVELOPMENT PERMIT FOR** THE DEVELOPMENT, **EXPANSION, MODIFICATION** OR OF **STORAGE** WAREHOUSES, DISTRIBUTION CENTERS, AND SIMILAR USES IN ALL INDUSTRIAL ZONES WITHIN THE CITY OF RIALTO.

WHEREAS, currently, the development, expansion, and modification of storage warehouses, distribution centers, and similar uses are permitted by right in each industrial zone within the City of Rialto; and

WHEREAS, the City Council desires to have storage warehouses, distribution centers, and similar uses be conditionally permitted in all industrial zones within the City of Rialto rather than permitted by right; and

WHEREAS, the Conditional Development Permit process will allow the City to place conditions of approval upon the development, expansion, or modification of storage warehouses, distribution centers, and similar uses in all industrial zones within the City of Rialto to ensure that these particular type of uses are constructed and operated continuously in a manner that is consistent with the vision, objectives, and goals of the General Plan, Rialto Municipal Code, and any underlying specific plan; and

WHEREAS, the City desires to add sections to Chapter 18.66 and amend section 18.38.020 of the Rialto Municipal Code to address the warehouses and distribution centers, and similar uses, through the Conditional Development Permit process ("Zoning Code Amendment"); and

WHEREAS, the City of Rialto Planning Commission conducted a duly noticed public hearing on November 20, 2019 and, after receiving and hearing al testimony and evidence, found the Zoning Code Amendment to be in conformance with the vision, objectives, and goals of the General Plan and recommended approval thereof; and

WHEREAS, the City of Rialto City Council thereafter conducted a duly noticed public hearing on January 14, 2020 to consider the recommendation of the Planning Commission and, after receiving

8	Quality Act (CEQA) pursuant to Section 15378 of the CEQA Guidelines.
