A RESOLUTION OF THE BOARD OF DIRECTORS FOR THE RIALTO UTILITY AUTHORITY OF RIALTO. CALIFORNIA RESCINDING **RESOLUTION NO. 2-01** AND AUTHORIZING INVESTMENTS OF MONIES IN THE LOCAL AGENCY INVESTMENT FUND

WHEREAS, pursuant to Chapter 730 of the statutes of 1976, Section 16429.1 et. seq. was added to the California Government Code to create a Local Agency Investment Fund in the State Treasury for the deposit of money of a local agency for purposes of investment by the State Treasurer; and

10 WHEREAS, on June 5, 2001, the Board of Directors of the Rialto Utility Authority (RUA) adopted Resolution No. 2-01 authorizing the City Treasurer, Assistant City Treasurer, and Account Clerk II to deposit and withdraw funds from the Local Agency Investment Fund; 12 13 and

14 WHEREAS, the titles of the officers authorized to order the deposit or withdrawal of 15 funds in the Local Agency Investment Fund has changed; and

16 **WHEREAS**, the RUA must notify the State Treasurer's Office of the names and titles 17 of those authorized to order the deposit or withdrawal of funds in the Local Agency 18 Investment Fund; and

19 WHEREAS, the Board of Directors of the RUA hereby finds that the deposit and withdrawal of money in the Local Agency Investment Fund in accordance with Government 20 21 Code section 16429.1 *et. seq.* for the purpose of investment as provided therein is in the best 22 interests of the City of Rialto.

NOW THEREFORE, BE IT RESOLVED, by the Board of Directors of the Rialto 23 **Utility Authority as follows:** 24

Section 1. Resolution No. 2-01 is hereby rescinded and of no further force or effect.

26 Section 2. The Board of Directors of the RUA hereby authorizes the deposit and 27 withdrawal of Rialto Utility Authority monies in the Local Agency Investment Fund in the State 28 Treasury in accordance with Government Code section 16429.1 et. seq. for the purpose of

investment as provided therein, and verification of the State Treasurer's Office of all banking 1 2 information provided in that regard.

3 Section 3. The following public officers, or their successors in office, shall be authorized to order the deposit or withdrawal of monies in the Local Agency Investment Fund. The officer's titles are: City Treasurer, Assistant Treasurer/Investment Officer, and Deputy City Treasurer/Senior Accounting Assistant.

Section 4. This Resolution shall remain in full force and effect until rescinded by Board of Directors of the RUA by resolution and a copy of the resolution rescinding this resolution is filed with the State Treasurer's Office.
