A RESOLUTION OF THE UTILITY AUTHORITY OF THE CITY OF RIALTO, CALIFORNIA, APPROVING AN AMENDMENT TO INCLUDE ASSESSOR PARCEL NUMBER 0256-031-21 ON THE EXTRATERRITORIAL WASTEWATER SERVICE AGREEMENT FOR THE COLTON JOINT UNIFIED SCHOOL DISTRICT PROPERTY LOCATED AT 10750 LAUREL AVENUE, BLOOMINGTON, SAN BERNARDINO COUNTY.

WHEREAS, Colton Joint Unified School District, (the "Owner"), represents it holds lawful title to the property located at the 10750 Laurel Avenue, Bloomington, identified by Assessor Parcel Numbers 0256-031-01, 0256-031-02, 0256-031-03 and 0256-031-21 (the "Property") which is located outside the incorporated boundaries of the City of Rialto, (the "City"); and

WHEREAS, The Rialto Utility Authority (RUA) and Owner are parties to an Extraterritorial Wastewater Service Agreement on the 28th day of October, 2014 to provide wastewater service to the Property; and

WHEREAS, The Extraterritorial Wastewater Service Agreement did not include Assessor's Parcel Number 0256-031-21; and

WHEREAS, RUA currently operates a wastewater collection system in Laurel Avenue, and Owner connected the Property to Rialto's wastewater collection system; and

WHEREAS, Owner has, pursuant to the terms of an Extraterritorial Wastewater Service Agreement, committed to, at Owner's cost, sewer mainline extensions and lateral with connections from the building drain to the sewer main, including all road cuts, patching, permits and inspections; and

WHEREAS, RUA owns and operates the sewer main running along and within Laurel Avenue; and any other related and/or additional facilities used for the conveyance, treatment or disposal of wastewater originating in the Service Area and any extensions, expansions or

replacements of any of the above being hereinafter referred to as the "Rialto Disposal System"; and

WHEREAS, RUA has defined and established by Council Resolution a policy and administrative guidelines to provide for wastewater service outside the City's corporate boundaries; and

WHEREAS, in order to accommodate the conveyance, treatment and disposal of wastewater originating in the Service Area, RUA has agreed to maintain and/or construct the Rialto Disposal System and such related and/or additional facilities as may be necessary to adequately provide such service for the Service Area in perpetuity; and

WHEREAS, in consideration of RUA's agreement to provide adequate conveyance, treatment and disposal services to the Service Area, Owner has agreed to make payments described in an Extraterritorial Wastewater Service Agreement with respect to wastewater from the Property discharged into the Rialto Disposal System (such wastewater being "Service Area Wastewater") calculated at one point three (1.3) times the monthly rates charged by RUA to customers within Rialto, all on terms and conditions more fully set forth therein.

NOW, THEREFORE, THE RIALTO UTILITY AUTHORITY OF THE CITY OF RIALTO DOES HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

The First Amendment to the Extraterritorial Wastewater Service Agreement Section 1: authorizing the inclusion of Assessor's Parcel Number 0256-031-21 for the property located at 10750 Laurel Avenue, Bloomington, San Bernardino County, is hereby approved as submitted to RUA concurrently with its adoption of this Resolution.
