## RESOLUTION NO.\_\_\_\_

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO, CALIFORNIA, APPROVING AND ADOPTING THE ANNUAL APPROPRIATIONS LIMIT FOR FISCAL YEAR 2020/2021

**WHEREAS,** the State Constitution places various limitations on the appropriations of state and local governments; and

**WHEREAS,** the Appropriations Limit for the City of Rialto for Fiscal Year 2020/2021 has been calculated using the percentage change in per capita personal income and the county's annual population percent change, which is in accordance with the provisions of the State Constitution; and

**WHEREAS,** the information necessary for making these calculations is available in the City's Finance Department; and

**WHEREAS,** the City of Rialto has complied with all the provisions of the State Constitution in determining the Appropriations Limit for Fiscal Year 2020/2021.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIALTO DOES HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

Section 1: That the maximum limit for 2020/2021 fiscal year's appropriations from 'Proceeds of Taxes' shall be \$84,999,231 and actual appropriations from 'Proceeds of Taxes' submitted in Fiscal Year 2020/2021 for the City of Rialto shall be \$61,320,187 based on attached calculations; and

**Section 2:** That the City of Rialto reserves the right to recalculate said limitation at a future time.
