13 the prior year's operating budget for up to 60 days.

14 NOW, THEREFORE, THE RIALTO HOUSING AUTHORITY OF THE CITY OF
15 RIALTO DOES HEREBY FIND, DETERMINE, AND RESOLVE AS FOLLOWS:

16 Section 1: That the Rialto Housing Authority of the City of Rialto does continue the
17 2019-2020 annual budget in full force and effect until September 30, 2020 or adoption of the Fiscal Year
18 2020-2021 budget.
