General Plan Amendment No. 2019-0004: A request to change the general plan land use designation of approximately 3.17 acres of land (APNs: 0250-091-25 & -26) located on the east side of Cedar Avenue approximately 630 feet north of San Bernardino Avenue from Residential 6 to Residential 12. A Mitigated Negative Declaration (Environmental Assessment Review No. 2019-0033) has been prepared for consideration in conjunction with the project. (Applicant: MV AMCV, LLC)

Zone Change No. 2019-0003: A request to change the zoning designation of approximately 3.17 acres of land (APNs: 0250-091-25 & -26) located on the east side of Cedar Avenue approximately 630 feet north of San Bernardino Avenue from Single-Family Residential (R-1C) to Multi-Family Residential (R-3).
