## RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIALTO, CALIFORNIA REPEALING RESOLUTION NO. 7594 ADOPTING BY REFERENCE SECTION 18730 OF TITLE 2 OF THE CALIFORNIA CODE OF REGULATIONS AND ANY AMENDMENTS TO IT ADOPTED BY THE FAIR POLITICAL PRACTICE COMMISSION AND DESIGNATING POSITIONS AND DISCLOSURE CATEGORY FOR FAIR POLITICAL PRACTICES COMMISSION FORM 700 FILERS

WHEREAS, The Political Reform Act (Gov. Code §§ 81000, et seq.) ("Act") requires state and local government agencies to adopt and promulgate conflict of interest codes. The Fair Political Practices Commission has adopted a regulation (2 California Code Regs. § 18730) that contains the terms of a standard conflict of interest code, which can be incorporated by reference in an agency's code. After public notice and hearing, the standard code may be amended by the Fair Political Practices Commission to conform to amendments in the Political Reform Act. Therefore, the terms of 2 California Code of Regulations Section 18730 and any amendments to it duly adopted by the Fair Political Practices Commission are hereby incorporated by reference. This regulation and the attached Appendices, designating positions and establishing disclosure categories, shall constitute the conflict of interest code of the City; and

WHEREAS, individuals holding designated positions shall file their statements of economic interests with the City, which will make the statements available for public inspection and reproduction. (Gov. Code § 81008.) All statements will be retained by the City; and

WHEREAS, the City Council, as the Code Reviewing Body under the Act adopts, affirms and incorporates by reference the Conflict of Interest Code set forth in 2 California Code of Regulations Section 18730, including any amendment to it duly adopted by the FPPC ("Code"), on behalf of the City; and

WHEREAS, the City Council previously adopted a Code which established disclosure categories and included a list of designated positions required to file a Statement of Economic Interest through Resolution No. 7594; and

WHEREAS, changed circumstances, including the establishment and deletion of certain departments, positions, as well as changes in job titles and responsibilities necessitate changes in setting forth the list of designated positions.

**NOW, THEREFORE, BE IT RESOLVED**, by the City Council of the City of Rialto, California, that the City Council has determined that the Conflict of Interest Code is approved as listed in Exhibit A and all resolutions previous to or in conflict with this resolution are hereby rescinded.
