Background



- Housing Element Update initiated on March 9, 2021
- Final Housing Element due to the State by October 15, 2021
- Community input is a vital component of the update
- We invite the community to "Plan to House Our Rialto"

Campaign Elements



- Workshops, Survey, and Public Hearings: Will offer several opportunities to provide feedback to staff and decision-makers
- Website: www.yourrialto.com/HouseOurRialto provides basic information now and will be updated with new content during the campaign
- E-Mail Sign Up: The website contains a link to sign up for updates
- **Postcard/Flyers:** A kick-off postcard will be mailed to mail routes with low- to moderate-income Census block groups and residents most vulnerable to housing challenges and flyers will be distributed throughout the campaign in English and Spanish
- Social Media: Regular posts about news and updates
- Engagement Partners: Volunteers who will share information with their community networks to broaden engagement



- "Plan to House Our Rialto" Installations: In three public locations to get information and provide comments
- Stakeholder Interviews: Participants with specialized knowledge or interest in housing will be interviewed for their unique perspectives
- Engagement Partners: Stakeholders with strong community ties will be invited to:
 - Provide input to staff
 - Distribute flyers and share information with their community networks

 - Comment on the draft plan at City Council on August 10
- Phase 4: Final Review and Adoption
 - August-October, stakeholders will have the opportunity to:
 - View the final draft of the plan online or in up to three public locations
 - Comment on the final draft plan at Planning Commission on Sept. 15
 - Comment on the final draft plan at City Council on Sept. 28
